

**MINUTES**  
**SUN CITY ANTHEM HIKING CLUB**  
**GENERAL MEETING – Nov 4, 2019, 6:30 PM**

1. Meeting was called to order by Greg Waterman
  - a. Greg Waterman determined we had reached and surpassed the quorum of 38 members required for the election.
  - b. Greg Waterman introduced new members to the club.
  - c. Kim Odegaard moved that the minutes of the November 4, 2019 meeting be approved as submitted, Susan Dona seconded. Membership voted approval.
  - d. Greg reminded membership that Hiking Hats with club logo were available for sale.
  
2. Election

Ballots were distributed to members at the door when they arrived. The people running were Susan Dona for President and Jim Boardman for Treasurer.

  - a. Greg Waterman asked for any additional nominations for the positions of President and Treasurer. There were none.
  - b. Members were requested to fill out their ballots and place them in the ballot box provided.
  - c. Greg Waterman let members know that the results of the election would be announced later in the meeting after the Nominating Committee had the opportunity to count the votes.
  - d. The Nominating Committee (Bill Brown and Martha Scott) adjourned to count votes.
  
3. Membership Chair – Susan Dona

Susan announced we have 54 new members for a total of 257 members. She reminded the membership that annual dues

are due on or before December 31, 2019, and can be paid via our website.
