- 6. Survey Results Kim Odegaard
 In answer to requests by members during the survey, the Board suggested that we:
 - a) Add a tab on the website for Volunteer Opportunities and give contact information (name, email, phone number) to folks who want to sign up for specific tasks.

- b) Give education on how to use the website at a meeting, so members understand what's available.
- Add a social gathering/meeting in the evening for Spring/Fall trips when possible.

- f) Members would like to see new hikes that are in new areas, so they aren't always doing the same hikes every year. The Board felt this was worthy of consideration, although our location limits where we can go to some degree. We are always looking for new hikes.
- g) Investigate alphabetizing the hike lists on the Website.
- h) Investigate auto-populating the sign-up section for the hikes once the member enters his or her name.
- i) Have a Happy Hour on the patio (perhaps after a monthly meeting).
- j) Members asked for more lunches after hikes. The Board discussed asking a question on the sign-up sheet for hikes to see if the hiker would be interested in going out for lunch or a beer after the hike. If enough are interested the hike leader make lunch plans from this list.
- k) Have an Ice Cream Social after the first general meeting of the season.
- I) Create a summary of survey results for the members with the actions we have taken.
